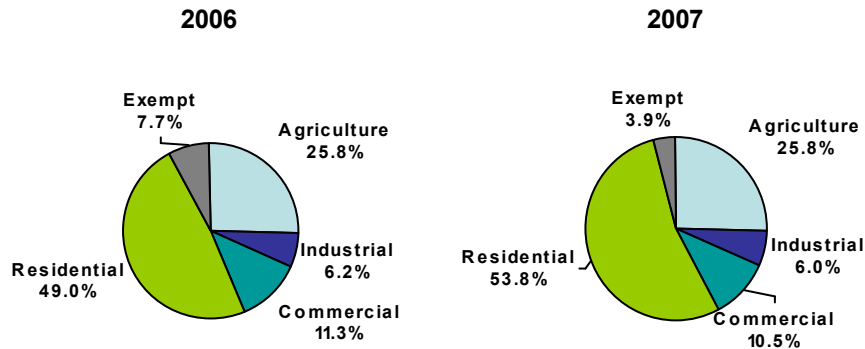


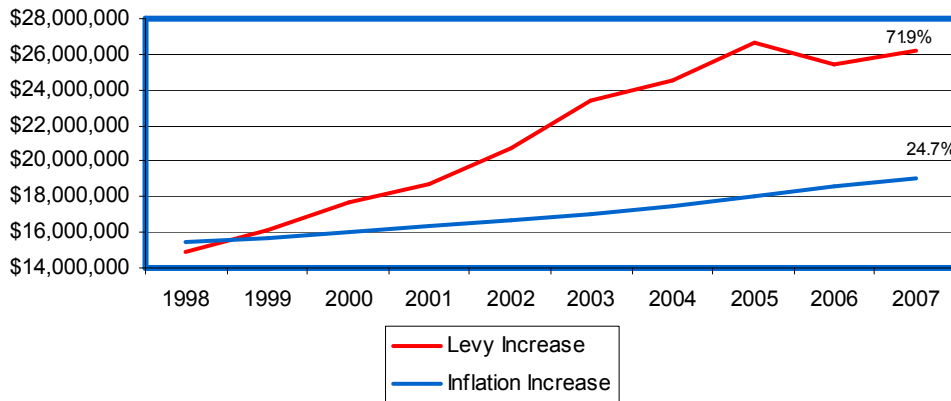

Spending Change

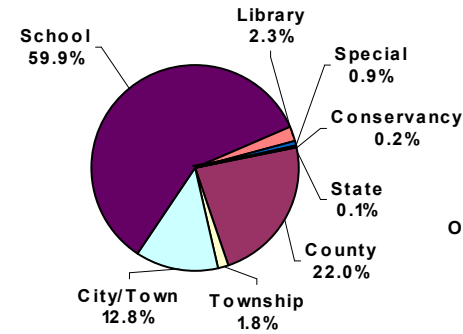

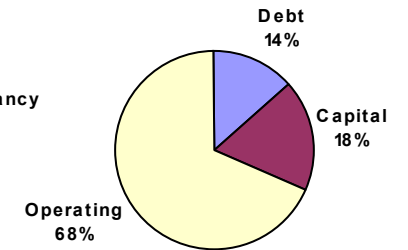
