

BOARD OF PUBLIC WORKS AND SAFETY MEETING  
JANUARY 4, 1999  
TIME: 8:30 A.M.

PRESENT: Mayor Frank Manus and Herb Scheidler. Bob Porter was absent due to surgery.

Minutes were approved.

Discussion was held on adjustments on sewer bills when there has been water leaks. Board asks Donna Lecher, Water Office Manager to write up a policy. After reviewing 13 requests it was decided to make sewer adjustments to 10 of the requests and 3 were denied. It was discussed that if the water does not go through the sewer, adjustment might be possible if receipts showing proof of repair are presented and Board approves.

**Nash - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$150. All ayes. So passed.**

**Kennedy - Motion by Herb Scheidler and seconded by Frank Manus to deny any credit on sewer. All ayes. So passed.**

**Darbin - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$182.62. All ayes. So passed.**

**Kazamis - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$3.84. All ayes. So passed.**

**Knox - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$25.06. All ayes. So passed.**

**Baugh - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$4.94. All ayes. So passed.**

**Swango - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$30.61. All ayes. So passed.**

**Ryle - Motion by Frank Manus and seconded by Herb Scheidler to deny credit on sewer. All ayes. So passed.**

**Devis - Motion by Herb Scheidler and seconded by Frank Manus to approve credit on sewer for \$151.22. All ayes. So passed.**

**Godbey - Motion by Herb Scheidler and seconded by Frank Manus to deny credit on sewer. All ayes. So passed.**

Laker - Motion by Herb Scheidler and seconded by Frank Manns to approve credit for \$49.81. All ayes. So passed.

Vanderbur - Motion by Herb Scheidler and seconded by Frank Manns to approve credit for \$24.73. All ayes. So passed.

Michigan Crossing - Motion by Herb Scheidler and seconded by Frank Manns to approve credit for \$83.03. All ayes. So passed.

Mayor stated that the Water Board had passed at their December meeting authorizing City Attorney, Steve Taylor to pursue with finding out who has jurisdiction on supplying water to the new Subdivision of Gorman/McCamment. Rural Water says they are to supply the water. This area has already been annexed into the City. Steve explained to Herb Scheidler that former city attorney, Frank Hamilton, Jr. has given him a letter from his file on Rural Water where it speaks of a jurisdiction area for the City, but Steve has not been able to find any map where this was established.






Motion by Herb Scheidler and seconded by Frank Manns to give City Attorney, Steve Taylor to proceed with necessary action against Mrs. Deerflinger and her property on N. Carver St. All ayes. So passed.

Mayor told the Board that he is looking into the Health Insurance. There is a big chance of going to Self-Insured. If this happens there would be a take over. Would have the same company and exact same coverage. Mayor explained how self-insured works.
