

COMMON COUNCIL MEETING

OCTOBER 4, 1999

TIME: 6:00 P.M.

PRESENT: Mayor Frank Manus, Roy Middendorf, Jr., Helen Gardner, Larry Bower, Glenn Tebbe and Bruce Tressler.

Minutes were approved.

Motion by Larry Bower and seconded by Glenn Tebbe to pass Resolution 1999-16 Amending 4.8 Personnel Policy. All ayes. So passed.

Motion by Glenn Tebbe and seconded by Roy Middendorf, Jr. to pass on 1st reading Ordinance 1999-16, 1999-17, 1999-18 Annexation. All ayes. So passed.

Motion by Larry Bower and seconded by Helen Gardner to pass on 1st reading Traffic Ordinance 1999-13. All ayes. So passed.

Kathy Crippen stated traffic control committee has nothing to report at this time.

Glenn Tebbe explained the new zoning Ordinance and recommended the passage of this Ordinance. Glenn stated the Plan Commission and Kathy Crippen have worked on this for the past two years.

Motion by Helen Gardner and seconded by Larry Bower to pass on 1st reading New Zoning Ordinance 1999-15. All ayes. So passed.

Motion by Glenn Tebbe and seconded by Roy Middendorf, Jr. to pass on 1st reading Salary Ordinance 1999-12 Amending Ord. 1999-4. All ayes. So passed. Motion by Glenn Tebbe and seconded by Roy Middendorf, Jr. to suspend the rules and regulations. All ayes. So passed. Motion by Bruce Tressler and seconded by Larry Bower to pass on 2nd reading Ordinance 1999-12. All ayes. So passed. Motion by Larry Bower and seconded by Roy Middendorf, Jr. to pass on 3rd reading Ordinance 1999-12. All ayes. So passed.

City Attorney Steve Taylor explained that there are some cities that have an agreement with Metro TransMit L.L.C. on the running of fiber optic cables thru their cities. Steve stated Darren Burkhardt of HNTB is going to contact Metro TransMit L.L.C. Engineers about the City of Greensburg's sewer main that is being planned to be put in.

Motion by Bruce Tressler and seconded by Helen Gardner to pass on 1st reading Ordinance 1999-19 Fiber Optic Cables. All ayes. So passed.

Motion by Helen Gardner and seconded by Glenn Tebbe to transfer GIE Insurance monies from the General to Police and Street repair appropriations. All ayes. So passed.

Council set Trick or Treat hours for 5:00 -8:00 P.M. on Saturday Night October 30, 1999.

Mayor Manus stated the City's health insurance carrier Central Benefits has stated a 5% increase for the year 2000 and the mayor is going to try and get it reduced to a zero increase.
