

ORDINANCE 2007-07-14

AN ORDINANCE FIXING SALARIES OF APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF GREENSBURG, INDIANA FOR THE YEAR 2008.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENSBURG, INDIANA.

SECTION I

Weekly salaries set forth in this Ordinance will be compensation beginning for the first work week with a period ending date in January 2008, payable the *second* Friday in January 2008, and there after each week. The following appointed officers and employees of the City of Greensburg, Indiana shall receive the following salaries:

SECTION II.

The City of Greensburg positions classified as Professional/ Administrative/ Technical/ (PAT), which are exempt, and the position of Chief of Police and Fire Chief are distinct within the salary ordinance and exempt from longevity pay ordinance and other rank and/or special pay categories. The Fire Marshall position, which is non-exempt, is classified as Protective Occupations, Law Enforcement (POLE).

However in years where no raise is given to all employees, the following exempt employees will receive compensation deemed by the governing board.

Persons holding the positions are to be paid a weekly salary.

The salary is to reflect the responsibilities, duties and functions of the position and take into consideration the education, training, experience and other qualifications of the person.

Weekly salaries set forth in this Ordinance will be compensation beginning the first work week with a period ending date in January 2008, payable the *second* Friday in January, and there after each week.

EXEMPT EMPLOYEES:

SALARY IS TO BE ESTABLISHED BY THE MAYOR AND MUST BE WITHIN THE ESTABLISHED AMOUNTS SET FOR THE RESPECTIVE POSITION AS FOLLOWS:



The Water Superintendent, Sewer Superintendent, and Utility Office Manager salaries will be paid from the Utilities Office. Planning and Zoning salary will be divided between the City and the Utilities Office.

SECTION III.

Salaries of the Water and Wastewater Utilities shall be established by a separate Ordinance. BE IT ORDAINED that this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor, subject to approval of the annual budget of the City of Greensburg by the Department of Local Government Finance. Salaries contained herein may require reduction in sum if such approval by the Department of Local Government Finance does not grant Tax Levies as requested by the Common Council of the City of Greensburg, Indiana.



ORDINANCE 2007-07-15

AN ORDINANCE FIXING THE SALARIES OF ALL ELECTED OFFICES OF THE CITY OF GREENSBURG, INDIANA, PAYABLE FROM THE GENERAL FUND, EFFECTIVE FOR THE 2008 BUDGETING YEAR AS PROVIDED FOR THE IC 36-3-2,35-4-72 AND 36-5-3-2 AS AMENDED.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENSBURG, INDIANA,

SECTION I. That all salaries of the Mayor, Clerk-Treasurer, and each member of the Common Council, effective commencing of the term payable from the General Fund of said City, shall be the following amounts:

MAYOR.....per year.....\$52,000.00
(Salary is split equally between City and Utility Funds)

CLERK-TREASURER.....per year.....\$41,000.00
(Salary is split equally between City and Utility Funds)

COMMON COUNCIL.....per quarter....\$1,000.00

The Mayor and Clerk-Treasurer's salaries will be paid on a weekly basis. The above salaries will be in effect beginning the first week with a work period ending in January, payable the second Friday in January, 2008.

SECTION II. The Clerk-Treasurer is ordered and directed to publish this Ordinance twice in two newspapers of general circulation in the English language in said City, the first publication shall be at least 30 days prior to the date of passage of this Ordinance.

SECTION III. This Ordinance shall be in full force from and after its passage and shall be effective as to the salaries provided on and after January 2008.




