The government does not financially support the Downtown Greensburg Development Corporation.

Board:

The board of the Downtown Greensburg Development Corporation is not appointed by any government entity.

Prospective directors are selected by a nominating committee, who have been appointed by the president of the board. A slate of nominees are presented to the board and are elected to the board by a majority vote of the board.
